Spanish Peaks Mental Health Center (SPMHC) provides licensed clinicians at the school Wellness Center, Behavioral health services offered at the Wellness Center include individual, group, and family therapy. Case management services include phone support, collaboration and consultation with Pueblo School District 60, Pueblo City and County Health Department, SPMHC, Pueblo Community Health Center, Pueblo Police Department, 10th Judicial District, Crossroads Turning Point, Pueblo District Attorney and Parkview Hospital.

# Program Type

- Collaboration on-site in an integrated system (mental and primary healthcare provided at a shared facility).
- Direct Clinical Service; Consultation; Referrals
- During the first year for all of the District 60 schools involved in school-based integrated care clinics, there were a total of 2,311 services provided to 409 unduplicated clients. The average number of resources per student was 5.65.

## Operational Resources

- Spanish Peaks Mental Health Center provides 1.0 FTE, dividing time between East High School and Risley Middle School.
- Pueblo Community Health Center (PCHC) provides necessary staff to provide full range of primary care services to students.
- Each organization provides the necessary supports to ensure that access to the clients' primary or behavioral health records is available.
- Each entity is responsible for the supervision, technical resources and operational supplies to support the healthcare delivered by its staff. Joint staffings are done collaboratively but staffing is maintained separately.

## Fiscal Resources

- Funding has been provided through two separate grants. The first was collaboration with Parkview Hospital and is funded by the Colorado Department of Public Health and Enviornment (CDPHE). The second was funded by the Federal Department of Education.
- Services are billed to Medicaid, CHP+ and private insurance. For those without insurance, a sliding fee scale is used.
