The Internet offers a meaningful opportunity to extend support—while helping to address the obstacles of cost, stigma and access that inhibit many from receiving appropriate care for mental disorders. This presentation will focus on emerging trends in online behavioral health and best practices for Web-based engagement. Additionally, to provide a practical illustration, a recently launched pilot involving Arapahoe/Douglas Mental Health Network and myStrength, Inc., a Denver-based online health and wellness company, will be discussed.



**Scott R. Cousino** is the CEO of myStrength, Inc, an online health and mental wellness company based in Denver. Prior to myStrength, Scott was an Internet executive at Alta Colleges, and was responsible for the initial launch and rapid growth of the company's fully accredited, Web-based learning platform. As President of the online college, Scott led an organization of over 600 employees and achieved a 45% increase in revenue (\$115 million) and five-fold increase in EBITDA margins. Scott has an MBA from the University of Colorado and a BBA with distinction from the University of Michigan.
