COMMUNITY MENTAL HEALTH CENTER& BHO RELATIONSHIPS

Community Mental Health Center/Clinic Member ("CMHC Member")

CMHC Membership is open to mental health centers and clinics, as defined by state statute, from which the State of Colorado Department of Human Services purchases mental health services. CMHC Membership may be granted by the Board of Directors in its discretion upon the recommendation of the Membership Committee or the recommendation of the Executive Committee. There are 17 Centers located throughout Colorado. Asian Pacific Development Center and Servicios de la Raza have also recently joined CBHC as full members.

Behavioral Health Organization Member ("BHO Member")

BHO Membership shall be open to Behavioral Health Organizations from which the State of Colorado Department of Healthcare Policy and Financing purchases services. BHO Membership may be granted by the Board of Directors in its discretion upon the recommendation of the Membership Committee or the recommendation of the Executive Committee.


The Colorado Mental Health Medicaid Program

The Colorado Medicaid Community Mental Health Services Program provides mental health care to Medicaid recipients in Colorado. Colorado's Mental Health Program is a capitated, managed care program. The state is divided into five (5) service areas. In each area the program is managed by a Behavioral Health Organization (BHO), formerly called MHASA.



BHO


Access Behavioral Care (ABC), is a division of a not-for-profit HMO, Colorado Access. *Access* Behavioral Care is a nonprofit organization that represents leading safety-net providers for mental health services for Medicaid consumers in Denver County. MHCD is a member of the Management Council of ABC and a partner of the BHO for the provision of Medicaid services.




BHI or Behavioral HealthCare, Inc. is a non-profit Managed Care Company that holds the Medicaid Mental Health contract in Arapahoe, Adams, and Douglas Counties, including the City of Aurora.




Foothills Behavioral Health (FBH) manages mental health benefits for persons enrolled in the Colorado Medicaid program and living in Boulder, Broomfield, Clear Creek, Gilpin or Jefferson Counties.



Northeast Behavioral Health, LLC (NBH) is the state-designated Behavioral Healthcare Organization operating to ensure the mental health treatment needs of Medicaid recipients in 12 counties of northeast Colorado are fully met.



Colorado Health Partnerships, LLC dba Colorado Health Networks (CHN) is comprised of providers, eight Community Mental Health Centers and ValueOptions, the leading public sector managed behavioral healthcare organization in the country. This Partnership includes three provider-owned LLCs: Pikes Peak Medicaid LLC, SyCare LLC and West Slope Casa LLC. These three LLCs encompass eight community mental health centers with responsibility for community mental health services is 43 counties.



Behavioral Health Clinics

The two behavioral health clinics, Asian Pacific Development Center and Servicios de la Raza have contracts with various BHOs for the provision of Medicaid services to culturally specific communities.
