Statewide Supportive Housing Expansion Project Updates

August 2023

Project Overview

In 2022, the Department of Health Care Policy and Financing (HCPF) and the Department of Local Affairs (DOLA) launched a joint venture to expand supportive housing across Colorado. Permanent Supportive Housing (PSH) is a housing intervention that helps those with a history of homelessness and complex barriers to housing stability lead stable, productive, and fulfilling lives. PSH combines affordable housing (through vouchers funded by DOLA) with wraparound supportive services designed to make sure people living with a disabling condition, including Substance Use Disorder (SUD) and Serious Mental Illness (SMI), can thrive.

With support of American Rescue Plan Act (ARPA) funding, the Statewide Supportive Housing Expansion (SWSHE) pilot project expands access to wraparound supportive services (including pre-tenancy and tenancy sustaining services) to promote housing attainment and retention to optimize health outcomes for Health First Colorado (Colorado's Medicaid program) members with complex needs.

Project Status

- Grant agreements with 28 PSH providers across the state.
- More than 600 Health First Colorado members receiving wraparound services through the pilot.

Project Impact

One example of the SWSHE pilot's impact is found in Alamosa County where the San Luis Valley Behavioral Health Group (SLVBHG) serves 40 SWSHE participants. According to Diamond Mobbley, Clinical Director of Intensive Programs at SLVBHG:

"SWSHE has been a breath of fresh air in a stifling housing environment. The success of the SWSHE program in our community cannot be understated. Our SWSHE participants have been given hope, support, and the resources needed to gain housing, remain in housing, or begin the housing process."
