We respond to community needs with a spectrum of care – outpatient, crisis, residential, wraparound services - for our state's most vulnerable individuals.


We carry out our work in partnership with policymakers and community partners to provide access to quality care throughout Colorado.

CO Behavioral Health Policy Landscape 2023

Less transformation, still some important developments

- HB 23-1236, BHA implementation update
- HB 23-1003, mental health screenings in 6th-12th grades
- HB 23-1071, psychologist prescribing authority
- SB 23-174, access to behavioral health benefits for children/youth in Medicaid
- Funding: 3% BH provider rate increase

Colorado

• New rules for behavioral health entity licensure

Nationally


- Sen. Bennet: Better Mental Health Care for Americans Act (parity)
- Reps. Pettersen/Neguse: Improved Access to Mental Health Care for Farmers/Ranchers (study I Matter-style free therapy for farmers, ranchers)
- Rep. Pettersen: HANDS Act (coverage for naloxone)
- Rep. Caraveo: Agricultural Crisis Hotline Act (988 offshoot for farmers, ranchers)



Ongoing Nationally

- Certified Community Behavioral Health Center (CCBHC)
 - Colorado applied for, did not receive planning grant; working on new grant application




