DENVER, Colo. — June 3, 2026 — The Colorado Behavioral Healthcare Council (CBHC) today announced that Crossroads' Turning Points, Inc. has officially joined the association as the first organization admitted under CBHC's Essential Provider & Safety Net Partner membership category.
